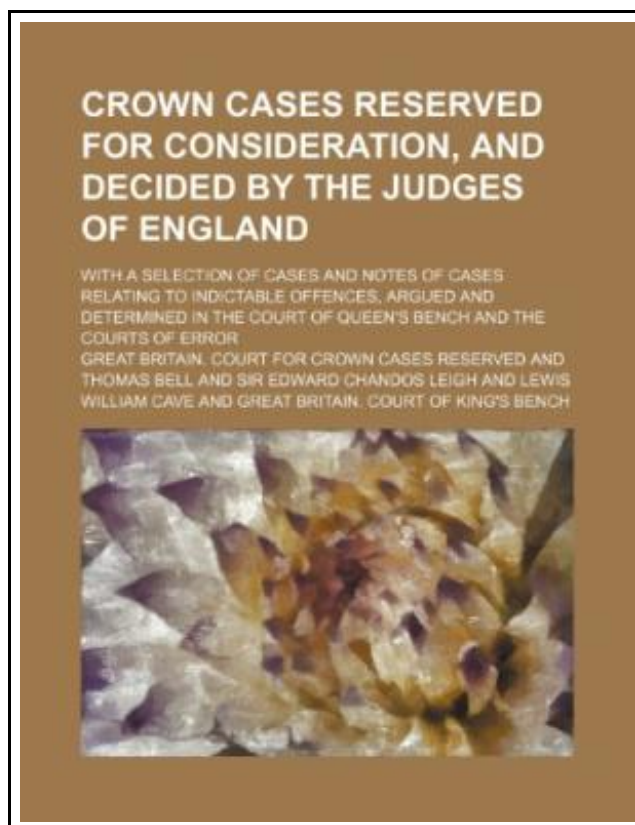

Upon each occasion when we made deposits with the bank there was an understanding between us and the bankers as to the amount to be placed to our credit, and this amount was calculated upon the estimated amount of the securities we lodged. Our account was not made up at the bank except half yearly, viz. , on the last day of June and the last day of December in each year. It appears from our pass book that, on the last day of June, 1857, there was a balance of 453. 15. Id. to our credit. It would be impossible for me to state now what securities the bank then held from us, nor how much the bank had then advanced upon the securities deposited. On each occasion when we deposited securities, the amount at which the securities were valued was placed to our credit, as so much cash. On the morning of the 14th of August, 1857, the balance to our credit at the City was about 2316. , but...
