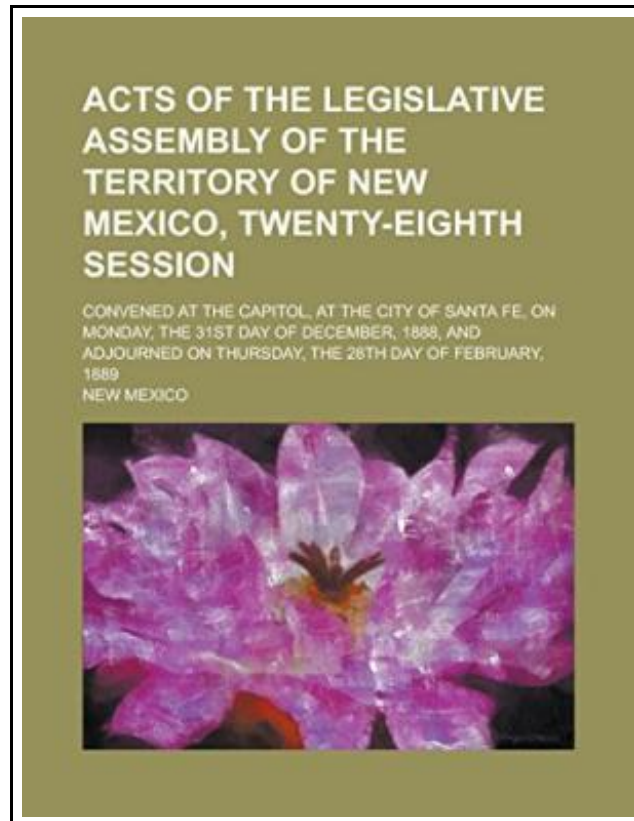

Excerpt: .as in the last section provided, he shall nevertheless grant letters testamentary to the executor named in the will, who shall act pending the final determination of the matter. SEO. 13. When a will has been approved any person interested may at any time within one year after such probate contest the same or the validity of the will. For that purpose he shall file in the court in which the will was proved a petition, containing his allegations against the validity of the will or against the sufficiency of the proof, and praying that the probate may be revoked. Sec. 14. Upon the filing of a petition a citation shall be issued to the executor and to all devisees and legatees named in the will residing in the territory, or to their guardians if any of them are minors, or their personal representatives if any of them are deceased, requiring them to appear before the court on the first day of the earliest term for which it is possible to give the required notice to show cause why the probate of the will should not be revoked. Such citation shall be served in the same manner and for the same time previous to the hearing as in the case of a writ of habeas corpus, provided as to the notice of the probate of the will, except that no publication shall be required.
